

# JEFFERSON COUNTY ORDINANCE # 10-04

AN ORDINANCE VACATING ALLEYS AND PORTIONS STREETS WHICH HAVE NEVER BEEN DEVELOPED OR USED AS PUBLIC STREETS IN THE TOWNSITE OF CAMAS, JEFFERSON COUNTY, IDAHO.

BE IT HEREBY ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF JEFFERSON, STATE OF IDAHO, AS FOLLOWS:

SECTION 1. All platted alleys located in blocks A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, and Blocks 1, 2, 3, 4, and 5 of the town site of Camas, Jefferson County, Idaho, as Amended/ Addition to Camas Town site recorded on November 10-14, 1915 and May 2, 1916 (Instrument number 4021, page 18 of the Jefferson County Plat Book and Instrument number 4894, page 19 of the Jefferson County Plat Book) are hereby vacated and the title to the center line of any platted alleys shall vest in the adjacent landowners as per their acceptance via letter to the Board of County Commissioners, Jefferson County, State of Idaho.

SECTION 2. All platted streets described as First Street, Second Street, Third Street, Fourth Street, Fifth Street, and West Main Street, Elk Street, and Antelope Street located within the town site of Camas, Jefferson County, Idaho, as Amended / Addition to Camas Town site recorded on November 10-14, 1915 and May 2, 1916 (Instrument number 4021, page 18 of the Jefferson County Plat Book and Instrument number 4894, page 19 of the Jefferson County Plat Book) are hereby vacated and the title to the center line of any platted streets shall vest in the adjacent landowners as per their acceptance via letter to the Board of County Commissioners, Jefferson County, State of Idaho. Excepting there from: The existing county roads and right-of-ways known as 2375 East also described as East Main Street on the platted town site; and 2650 North that runs through the north portion of blocks 1 and A.

**Appendix B:** Addition to Camas Town Site recorded May 2, 1916, instrument number 4894 copied from page 19 of the Jefferson County Plat Book.

SECTION 4. It is hereby decreed this ordinance shall be in full force and effect from its passage and publication in one issue of the Jefferson Start printed in Rigby, Jefferson County, Idaho, and the Jefferson County Clerk is directed to record this ordinance in the official records of the County of Jefferson, State of Idaho.
